TUITION FEES FOR 2022-23

**One Child - \$135 per month**

**Two Children- \$250 per month**

**Three Children - \$365 per month**

Tuition will run August 2022 – May 2023. All months will be the same tuition rate no matter the amount of days attended each month. **The registration fee is \$75 per child or \$120 per family.** Please note that registration will open to the public in March.

Your child's spot will not be held until your registration packet is complete. **The following items must be submitted for a complete registration:**
